- Emerging / ongoing concerns for turtles:
 - -bycatch: gillnet (all countries?), fish trawling (Surinam, Trinidad), shrimp trawling (Louisiana, Costa Rica, ?,?.) Longline (Suriname, Venezuela)
 - -Illegal Fishing
 - -poaching adults and eggs.
 - -unchecked oil drilling of coast of French Guiana 6000m
- Concerns for MTSG:
 - -Encourage and developing collaborative research capacities for bycatch mitigation.

Regional Opportunities

- New projects, opportunities:
 - Develop TED's for fish trawls in Suriname.
- Relevant new research
 - TED's for skimmer trawls in Louisiana-Reduced bar spacing for small turtles
- Gaps
 - No CPUE for gillnets (except FG, Martinique, Guadeloupe)
 - No CPUE for fish trawls in Suriname
- Opportunities for MTSG involvement in regional issues.
 - Encourage onboard observer programs.

- Species in need of regional assessments
 - Leatherbacks
 - Olive ridley
 - Green
- Status of regional assessments (ongoing support to global assessment processes, stand-alone assessments, etc)
 - Guiana's Leatherbacks (CNRS-Lebreton) first feed back april
